Fraud causes Marriage to be NOT legal: There are authorized marriage officiants/reverends who took away the Marriage Licenses from grooms and the brides before their wedding day. **Then, they illegally pre-signed on [Line 46 of the Marriage License](#) and the [Record of Solemnization of Marriage](#).** On the wedding day, marriage officiants/reverends who had illegally pre-signed on Line 46 of the Marriage License and the Record of Solemnization of Marriage do not show up to officiate (perform) the marriage at the wedding ceremony. Instead, they give the illegally pre-signed Marriage License to unauthorized substitute people to take to the wedding to officiate (perform) the marriage at the wedding ceremony, like a show! The reason for this is about money. The more unauthorized substitute people sent to officiate (perform) marriage at wedding ceremony, like a show, the more money will be made. **Marriages officiated (performed) in this way is absolutely NOT legal. It is a fraud!**

REASONS FOR MARRIAGE ILLEGALLY OFFICIATED (PERFORMED): (1) the authorized marriage officiant/reverend had illegal pre-signed on Line 46 of your Marriage License and your Record of Solemnization of Marriage; (2) the substitute person was unauthorized to officiate (perform) your marriage at your wedding ceremony; and (3) your marriage was officiated (performed) NOT properly and NOT legally.

All grooms & brides, if your marriage is NOT legal, it will negatively affect you in many ways, like spousal immigration application, Income tax and many other legal matters, etc....
